1. A form of authorisation, signed by the Parish Priest to this effect, is required
3. Children whose parent(s) (ii) live within three miles of the school and who are, and have been, regular and committed worshippers in churches that are members of **Churches Together in England** or the **Evangelical Alliance** for not less than one year before the closing date of application. A form of authorisation, signed by the Church Leader (iv) to this effect, is required.

**In the event that two or more applicants have equal right to a place under the Foundation Place Criteria, the Governing Body will give priority to those children living in nearest proximity to the school (v).**

**In the event that, in the period specified for attendance at worship, the church has been closed for public worship, and has not provided alternative premises for public worship during this period, the requirements of these admissions arrangements in relation to attendance will only apply to the period when the church or alternative premises have been available for public worship.**
